Need Directory Assistance...?

If your long distance carrier is Sierra Communications you are entitled to five (5) free In-state directory inquiries per month. You may request up to three (3) numbers per each inquiry call. Every call over five will be billed at a rate of twenty-five cents (\$.25) per call unless an operator assists you.

Operator assisted calls are \$1.30 per call, plus additional charges for extra service if applicable. Be very aware when making an operator assisted call. Make sure you understand the rates before you agree to the additional service (such as completing the call for you) or you may find extra charges on your phone bill.

Remember, rates for directory assistance vary by carrier. If you are not a Sierra Communications long distance customer you will need to contact your carrier to find out more about their rates for directory assistance.

Don't go digging up trouble.

Springtime is here and that means yard work, construction work, and a lot of digging! Please call us before doing any digging or dirt work and we will be glad to locate cable for you at no charge.

Repairing a major cable cut is very time consuming and can be very expensive

Costs incurred repairing cut cable will be billed to the individual responsible for the damage.

Troubleshooting your Internet Connection...

"The computer you are dialing into cannot establish a Dial-up Networking connection. Check your password and then try again."



This is a fairly common error message. If you get this message make sure your user name (not your entire email address) is correct and try retyping your password. If you still cannot log on it may be because you have a blocked plan and have used all your hours. Keeping tabs on your time throughout the month will prevent you from running out of time. To monitor your time online go to our website www.bacavalley.com and click on the Internet button. Then select "Check Time Online". Enter your user name and password. You will see your time reflected in either Time Remaining, if you have a blocked plan, or Time Used, if you have an unblocked plan. If you need to increase your plan give our office a call and we will be happy to make the necessary changes. Another possible reason for this error message is typing in an incorrect password. Give us a call to confirm your password.



When dealing with email attachments do not open them unless you're absolutely sure they're from a reliable source and you've scanned them with **up to date** anti-virus software. Send "fishy" messages directly to the trash (worse case scenario: you miss out on some forwarded joke) or email the sender to make sure they purposefully sent the attachment. This last step, checking with the sender to make sure they sent the file with the attachment, might delay opening the file, but it's worth it to keep from opening a file that could be a virus.
